#### 11.3 Planning Applications received.

Having declared an interest, the Chairwoman Cllr Miss H Downing handed the Chair over to the Vice-Chairman Cllr P Blease before PA23/09176 was considered.

## PA23/09176 - Land East of Pembroath Farm, Trembroath - Application for Technical Details 11.3(a) Consent (TDC) following Permission in Principle approval PA22/03505 dated 26/047/2022.

RESOLVED to NOT SUPPORT this application on the following grounds:

- 1. Previous concerns regarding risk of flooding have not been addressed sufficiently, the area flooded at the beginning of January and has yet to drain completely
- 2. Errors in the planning application which includes the position in relation to a water course - the Information is incorrect.
- 3. Highways it is felt that the access is not suitable for additional traffic.

4. The design of the building is not in keeping with the area.

Stithians Parish Council strongly challenge the classification of Trembroath as a 'settlement' and is of the opinion that this application is 'development in open countryside'

It also notes that a number of trees and shrubs were removed from the site pre application.
