12 ENVIRONMENTAL MANAGEMENT

12.1 *Notes/Update from EMC Meeting held on the 4th February 2025.*

1. Agree the content, actions and associated expenditure detailed in the notes.
2. To authorise T. Martin to hire a mini digger at cost of £350 to carry out the following works:
 - a) Move soil / turf to cover concrete base at site of old roundabout.
 - b) Dig drainage ditch to reduce 'standing water' on footpath near end of BMX track
 - c) To move trees from Crelow Fields Amenity Area
 - d) To move a suitable granite stone to bottom of stile on playing field.
 - e) Replace granite stone on wall / hedge in Meadowside.
 - f) Additional drainage works to be completed on the footpath – Cllr W Thomas to liaise with T. Martin.
3. Authorise the purchase of 13 tree guards' trees to be planted at Playing Field car park.
4. Authorise the purchase of 4 'inserts' for goal posts with budget of £150.00

12.2 *Footpaths, Highways and Environment Portfolio Holder's Report*

Cllr W Oakley-Moore requested an update on the concerns raised regarding the condition of the young trees, newly planted, around the site of the SWW Works at Stithians Dam. A report was also received regarding the gate from the field on to Old Vicarage Close, this is not a PRoW, but walkers are using this rather than the stile on the footpath, gate being left open which is causing an obstruction in the lane and blocking access to the residents on Old Vicarage Close.

South West Water to report the poor condition of the trees

Coastline to ask if the gate can be padlocked to ensure that it is no longer used as a right of way for pedestrians

- the relocation of the internal public toilet next to the external toilet,
- the footprint of the kitchenette to be increased and the hatch from the kitchen moved from behind the doors leading to the main room
- the plant / equipment room be accessible from the kitchen.

To confirm that the kitchen will be used for the preparation of hot / cold drinks and serving off light snacks / cakes, no cooking to be undertaken on the premises.
