- 1. Concerns regarding the suitability of the access lane to the property, especially with the potential of increased numbers of vehicles as a result of the holiday let.
- 2. Impact on the biodiversity of Rame Common. which lies immediately adjacent to the site.
- 3. Concerns regarding the 'self-build' structure and whether it meets all current building regulations and its suitability for accommodation.

It would also note that the building work completed on the site demonstrates a blatant disregard for planning regulations.
